The bidder may inspect the items/materials on any working days from 17.05.2022 to 06.06.2022 between 10,00am to 12.30 pm by prior appointment to satisfy themselves or otherwise about quality and conditions of the materials items offered. No complaints in this regard whatsoever will be entertained after the Tenders are submitted or before materials / items lifted. No request for samples or inspection after the submission of the tender will be accepted.

Tenders should clearly quote their rates lump sum/lot wise, kg/ per piece wise/ as per the annexure as asked for both in figure and words n inclusive of Taxes and Duties, any overwriting in rates or any change and or/ alteration without attestation liable to culminate in the outright rejection of the tender. In case there are any error between the amount specified and words, the higher of the two will be taken as consideration.
05. E.M.D /Bid **Security Rs-10,000.00/-** shall accompany the bids in the form of Demand Draft/ Bankers Cheque, bid without E.M.D/Bid Security **Rs-10,000.00** only will be summarily rejected. No interest will accrue on the EMD so Deposited.
06. Certification that the firm is not black listed from the CEO of the firm/ Notary shall be submitted.
07. EMD of the Successfully bidder /s will be kept with us and will be returned after satisfactory completion of the order. In case of deviation of the terms and conditions the recovery shall be made out of the EMD Deposited. In case the tendered materials are not lifted within the specified date and time, ground rent equal to Rs-100.00 per lot per day will be charged to the successful bidder for a further period of 7 days. The materials not so removed will be treated as abandoned lots and the EMD and other sums paid for the lot will be forfeited without any reference to the bidder. For such abandoned lots, The PRINCIPAL RIE Mysore shall have the right to resell. EMD of unsuccessful parties will be returned within 45 Days of the Opening of the Tender.
08. Force Majeure: Notwithstanding the provision of the contract, the bidder/firm shall not liable for forfeiture of its EMD or abandoned as stated. If and to the extent that, it's delay in performances or other failure to perform its obligation under the contract is the result of an event of Force Majeure. If a force majeure arises, the firm shall promptly notify the RIEM, in writing of such conditions and cause thereof. Unless otherwise directed by REGIONAL INSTITUTE OF EDUCATION MYSORE in writing, the firm shall continue to perform its obligation under the contract as for as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.
